

Affiliate Terms & Conditions

These Affiliate Terms & Conditions (“Terms”) govern participation in the Braham Affiliate Programme, operated by **Braham**. By registering as an affiliate, you agree to comply with these Terms.

1. Programme Purpose

The Braham Affiliate Programme exists to:

- Help small and micro-businesses access professional email and domain services
- Reward affiliates who make genuine, helpful referrals

This programme is built on **ethical promotion**, not spam or misleading marketing.

2. Eligibility

Affiliates must:

- Be at least 18 years old
- Provide accurate personal and payment information
- Promote Braham’s services in a truthful and responsible manner

Braham reserves the right to approve or reject affiliate applications at its discretion.

3. Commission Structure

- Affiliates earn ₦10,000 for every successful and completed sale of the Business Email & Domain package.
- This is a promotional commission, valid for 6 months from programme launch.

- There is **no cap** on the number of commissions an affiliate can earn during this period.

- Secure access to the existing domain (via cPanel or DNS settings) will be required.
- The commission remains the same.

8. Termination

Braham reserves the right to:

- Suspend or terminate an affiliate account at any time for breach of these Terms
- Withhold unpaid commissions related to fraudulent or abusive activity

Affiliates may also exit the programme at any time.

9. Relationship of Parties

Affiliates operate as independent promoters, not employees, partners, or agents of Braham. Nothing in these Terms creates an employment, partnership, or joint venture relationship.

10. Changes to These Terms

Braham may update these Affiliate Terms & Conditions at any time. Continued participation in the programme constitutes acceptance of any updates.
